Mission to India for Swiss Companies in the Machinery and Life Sciences Sectors October 24 to 31, 2010

INTRODUCTION

India's past growth, coupled with its relative resistance to the global economic downturn and political stability has generated an increased interest among Swiss SMEs in the country as a business destination. However, due to what are perceived as the operational complexities of the Indian market, Swiss SMEs are often hesitant to take first steps or uninformed about what these steps should be. Once in India, they often face the challenge of adequately protecting their interests.

SICC's Mission to India aims to assist Swiss SMEs in their efforts to export to and/or invest in India. The envisioned support will bring the following benefits to Swiss SMEs:

- Invest limited resources in a more strategic manner in order to achieve better business results in India.
- Add value to local Indian products, and/or introduce new products in response to the need for equipment and technologies.
- Identify and mobilize the right partners (managers and/or joint-venture partners).

The roadshow and mission is for SMEs in the following sectors:

- Equipment and machinery manufacturing (precision, electrical and non-electrical)
- Life sciences, pharmaceutical, bio-tech, med-tech and allied industries

The target sectors in India have been identified according to the following considerations:

- Compatibility with sectors where Switzerland has proven leadership and expertise;
- Sectors in India where existing consumer demand has not adequately been met;
- Sectors in India where potential market demand has been identified but remains dormant. In the latter case, Swiss SMEs have the opportunity to create new niche markets in the country.

The price categories are determined by a company's annual turnover (VAT will be added if applicable). The prices below cover the following in India: **domestic travel (bus and air), hotel accommodation incl. breakfast, 5 lunches and 5 dinners**. They do not cover the cost of the roundtrip air ticket Switzerland/India, visa processing fee, communications (telephone, e-mail, fax) and other business center expenses, drinks/snacks from the hotel mini-bar or purchased between meals in India. The costs of any one-on-one meetings and customized individual company visits including transportation costs will be charged separately.

- Companies with an annual turnover of up to CHF 5 million: **CHF 2500**
- Companies with an annual turnover from CHF 5 million to 50 million: **CHF 3400**
- Companies with an annual turnover of over CHF 50 million: **CHF 4800**

Cancellations received up to 20 days before the travel date will be charged 50% of the participation fee. Thereafter, payment is due in full. You are free to send a replacement at no extra charge until the domestic flights in India have been booked.

Participants are kindly requested to book their own roundtrip tickets Switzerland/India and arrange their visas for travel to India themselves.

- A completed and signed visa application form: www.consular-service.ch → Downloads → Indien
- Two passport photos
- Confirmation of return trip
- For non-Swiss nationals: A copy of Swiss residence permit

Health Recommendations

Participants are responsible for getting vaccinated. Please consult a doctor or the website www.safetravel.ch where the following vaccinations are recommended: diphtheria, tetanus, poliomyelitis, measles, hepatitis A and B, abdominal typhus, rabies and Japanese encephalitis.

You should under no circumstance consume raw fruit or vegetables, freshly-squeezed fruit juices and tap water (including ice cubes). Stick to properly cooked food, preferably Indian rather than Western cuisine.

Open neck shirt and jacket, or shirt and tie with jacket for men.

Currency

Travellers checks and credit cards are recommended. Be aware that cash machines are only readily available in big cities. Foreign currency in the amount of USD 5000 (in the form of cash or travellers checks) must be declared when entering the country.
